## *An Evening at the Theater*

Please join the Bexar County Family Justice Center Foundation on January 27, 2010 for their fourth annual fundraiser, An Evening at the Theater. This year, Vivienne Elborne will direct the comedy *Dearly Departed* by David Bottrell and Jessie Jones. Ms. Elborne has directed and acted in theatre in the United States, United Kingdom, Mexico, Ontario, Russia, and the Ukraine, and has also been inducted into the San Antonio Women's Hall of Fame and received the JC Penney Spirit of the American Woman Award. Her talents will be revealed through a cast of ten, including Bexar County's finest legal minds - Catherine Babbitt and Catherine Hayes.

*Dearly Departed* premiered at the Long Wharf Theatre in New Haven, Connecticut in 1991. That same year it received great critical acclaim in its Off-Broadway opening at the Second Stage Theatre in New York. The New York Daily News said that "Dearly Departed is drop dead funny...but don't take our word, see it yourself." *Dearly Departed* was then produced in Los Angeles where it received six Drama Logue Awards including "Best Production" and "Best Playwriting." It was subsequently published and has been produced in hundreds of regional theaters in the United States, United Kingdom, and Australia.

The play is about a family that proves that living and dying in the South are seldom tidy and always hilarious. Despite their earnest efforts to pull themselves together for their father's funeral, the Turpin's other problems keep overshadowing the solemn occasion: Firstborn Ray-Bud drinks himself silly as the funeral bills mount; Junior, the younger son, is juggling financial ruin, a pack of no-neck monster kids, and a wife who suspects him of infidelity in the family car; their spinster sister, Delightful, copes with death as she does life, by devouring junk food; and all the neighbors add more than two cents. As the situation becomes fraught with mishap, Ray-Bud says to his long-suffering wife, "When I die, don't tell nobody. Just bury me in the backyard and tell everybody I left you." Amidst the chaos, the Turpins turn for comfort to their friends and neighbors, an eccentric community of misfits who just manage to pull together and help each other through their hours of need, and finally, the funeral.

She also aided in developing the state guidelines for the violence intervention program for perpetrators. In the next week, several Family Service Association counseling interns will join Maria, and beginning January 1st, she starts two innovative and unique therapy groups that will meet in the afternoon or evenings and incorporate dance therapy, art therapy, health, nutrition and even computer training – all activities that will lead to empowerment and combat the desire to return to the familiar power and control relationship.

Also, please welcome a new partner and new child therapist, **Richard Amiss**, from **Saint PJ's Children's Home**. He is a Licensed Professional Counselor-Supervisor, National Certified Counselor and Clinically Certified Domestic Violence Counselor. He has much experience with adults, children and perpetrators of domestic violence. His focus includes healthy relationships/unhealthy relationships and personality disorders. Richard enjoys group work and is currently co-facilitating an adolescent girls group on self-image and an adolescent boys group on communication, respect and self acceptance at Saint PJ's where he has worked for eight years. Richard has been in the field of domestic violence for almost eleven years; interned at Family Violence Prevention Services; and has worked with CPS clients for nine years. He will be at the Family Justice Center every Monday. He will take walk in clients as well as scheduled appointments. Please welcome these accomplished and impressive new team members! We are so glad that they are here.
