The Partners also recognized gaps in service and agreed that more case workers, counselors, housing advocates and attorneys were needed to serve the 4,000 families who flow into the Family Justice Center every year

seeking help. The Partners also saw the need for a common database to track and share information about clients so they could help them more quickly and efficiently without repetition.

Additionally, the Partners developed **KEY STRATEGIES** for the coming year that would make the biggest difference in improving services to victims. The Community of Partners have agreed to hold regularly scheduled meetings, develop a computer information system, act on client input to the process, educate key players in the domestic violence arena and educate the community, especially in the schools, on signs and symptoms of domestic violence. The Administration at the Family Justice Center and the Family Justice Center Foundation is **LISTENING** and looking forward to helping, coordinating and supporting the Partners fulfill their **DREAMS** for the Center. With such support and effort behind helping victims of domestic violence in the San Antonio community, this group will reach and go beyond their goals.
